

## WOD WAR 4 MORI 2022 REGULATIONS

This document contains general information about WodWar4Mori sports event (hereafter abbreviated as WW4M).

Each athlete signing up and accepting the participation to the event, declares to have read and agreed to the rules and any further information explained. The following regulation is an integral part of the act of participation in WW4M.

### SUBJECT

It's a great sports event dedicated to fitness which will take place in Alghero (Italy) and will last three days, more specifically on the 2nd, the 3rd and the 4th of September, 2022. It is all organized by Insula Event and Bad Boars CrossFit with the aim of promoting both amateur and professional sports activities. **WW4M is a team competition of 4, the teams must consist of 2 women and 2 men.** Athletes can sign up for WW4M by registering through the following link: <https://www.judgerules.it>

### ADMISSION REQUIREMENTS

- Being 18 years old at the time of participation or being authorized by the parents of the minor.
- Accepting rules and regulations about discharge of liability and personal data processing.
- Having completed the registration through the link and paid the participation fee of €120 + commission (€150 from January 16th) in order to have the access to the online qualifications.

### REQUIRED DOCUMENTS FOR THE FINAL STAGE OF WW4M

- a valid medical certificate for competitive sports activities
- Identity document (ID)
- Copy of the e-mail that proves the qualification
- For minors, authorization to participation signed by parents and accompanied by a photocopy of the signer's document.

### CATEGORIES

Categories are as follows:

- Elite
- Open
- Master Young (over 35 years old)
- Master Classic (over 45 years old)

### CATEGORY STRUCTURE

Online qualifications will give access to the finals for a number of teams divided by the following categories:

- Elite 24 teams (+8 wild cards)
- Open 32 teams
- Master Young 32 teams
- Master Classic 32 teams

The organization reserves the right to offer access to the finals to other Athletes deemed deserving it without going through the qualifications. The selection of athletes who will access the finals will be made through 2 WODs qualifications which will be published on [www.ww4mori.com](http://www.ww4mori.com) website.

Participation wods will be individual and the scores of each athlete in the team will be added in order to obtain the final ranking of the team. A male and female ranking will be drawn up, in the event of a tie in the team score, the best male and female ranking will be taken into consideration.

### **REGISTRATION**

The registration date is set for November 22nd, 2020.

Those who wish to register must fill out the registration form on the Judge Rules platform and pay the fee of:

€ 120 + commission expences per team up to January 15th

€ 150 + commission expences per team from January 16th.

Athletes who will receive an e-mail with a confirmation of the qualification to the finals will have to pay an additional fee that will be later announced on the [www.ww4mori.com](http://www.ww4mori.com) website.

Participation fees can not be refunded for any reason, except for the cancellation of the event by the organization.

### **VIDEO VALIDATION**

The WODs must be filmed, uploaded on public mode on the YouTube platform and then the link must be uploaded on the [www.judgerules](http://www.judgerules) portal.

In order to validate the video it will be necessary to register it following the criteria that are indicated when each WOD is announced.

The equipment used for the WODs must only be standard equipment.

Modifying or retouching the video will lead to its cancellation and the disqualification of the athlete from the event.

## **DISCLAIMER AND CODE OF CONDUCT DURING THE EVENT:**

Each athlete who participates in the WW4M event, upon registration, accepts what is contained in the regulations.

All participating athletes agree to respect the principles of a competition by behaving in a fair and sporting way. All athletes will also be committed to respecting the correct behavior towards other athletes, judges, volunteers and Staff.

Offensive verbal comments, violent discussions, harassment, threats, provocations, obstacles and annoyances towards other athletes, judges, volunteers and Staff will not be accepted whatsoever and taken into legal action. Damages or impediments that interfere with the fair and proper conduct of the event, against the organization, participants, sponsors, spectators or others present will be punished by penalties to their ranking.

The judgment of the judges cannot be questioned, and their word will be final and incontrovertible, as well as the one from the organization. Furthermore, videos made by outsiders will not be taken into consideration, nor videos made by outsiders that question the reason for the dispute.

**DECLARATION OF RESPONSIBILITY:**

Each athlete who by enrolling decides to participate in the event, declares under his responsibility to accept the following regulations in full.

Each athlete informed of the activity that will be carried out during the event must present a valid medical certificate for competitive sports, having consulted in advance a sports doctor who will ensure the good health condition and a good condition to carry out the required sporting activities.

Each athlete also declares to be in a good health condition and not to have physical deficiencies that would compromise their participation in the event, making it dangerous for their health.

Each athlete is responsible for any injury caused to himself or others releasing the organization from any type of civil or criminal liability.

Each athlete declares to habitually practice sports.

Each athlete declares to be aware that the activities that will take place during the event may involve serious health risks (also causing disability, death and consequent socio-economic losses), due to bad behaviors, negative attitudes towards both themselves and towards other participants in the event. By accepting these conditions, each athlete therefore takes all responsibility for acts due to their behavior also and especially in relation to the previous point. Each athlete agrees to waive, either in person or through other representatives, heirs or next of kind, any actions for damages for personal or material damage against the organization within the limits imposed by the Italian law.

This also applies to their accompanying staff.

This also applies to their companions.

Each athlete declares that he/she authorizes the organization to provide emergency medical treatment through qualified personnel present at the event.

Each athlete therefore expressly agrees, with this regulation and in respect of the organization, to release it from any liability and compensation under Italian law.

Each athlete accepts exclusively the Italian Jurisdiction and the competence of the court of the place where the event takes place in relation to any action taken by the organization in relation to any action arising from the event itself.

Each athlete agrees to the following regulations releasing the Organization from liability and compensation in a broad and

inclusive of what is permitted by Italian law that if any part of this agreement is deemed invalid you agree

that the remaining regulation nevertheless remains fully valid and effective.

## **PRIVACY POLICY:**

Wod War 4 Mori Organization, as the holder of the process, informs all athletes that it will use the personal data provided at the time of registration, in order to allow you to join every stage of the organization of the event; to fulfill the legal obligations relating to the organization of the event, as provided for by the civil, fiscal and

accounting for the purposes of administrative management of the relationship; to disseminate or promote to the public the event by sending promotional emails and future initiatives by Wod War 4 Mori Organization or other companies associated with for the purposes of art. 2359 of the Civil Code.

The personal data requested are required for the purposes described above. In case of refusal, Wod War 4 Mori Organization will not be able to allow the athlete to participate in the event.

The processing of personal data will be done through manual, computerized and telematic tools, closely related to the purposes outlined above and in any case by authorized persons and appropriately aware of the constraints imposed by D.Lg. 196/2003, equipped with security measures to ensure the confidentiality of personal data and to avoid possible accesses by third parties and unauthorized outsiders.

In addition, athletes authorize the use of their images in photographic representations, audio and video contents or other forms of reproduction that will be made through the website social network channels of the event Wod War 4 Mori and on [www.www4mori.com](http://www.www4mori.com) website, facebook pages, twitter and istagram and on any other advertising material in paper format or electronic. Processing of personal data will be done through manual, computerized and telematic tools, with logic closely related to the purpose outlined D.Lg. 196/2003, equipped with security measures to ensure the confidentiality of personal data and to avoid possible accesses by third parties and unauthorized outsiders.

In addition, athletes authorize the use of their image, in photographic representations, audio and video content or other forms of reproduction that will be made through the website social network channels of the event Wod War 4 Mori and [www.www4mori.com](http://www.www4mori.com) web site, facebook pages, twitter and istagram any other advertising material in paper format or electronic. Personal data will not be disclosed and will be used exclusively for the purposes described above.
